IS NOT RESPONSIBLE SHOULD MY BOAT BE STOLEN, VANDALIZED, OR DAMAGED DUE TO THE REMOVAL OF MY BOAT OR ANY TIME THEREAFTER. I ALSO UNDERSTAND THAT A BOAT STORAGE FEE OF \$50.00 WILL BE IMPOSED UPON ME AND MY BOAT MAY BE SUBJECT TO SALE TO PAY SAID STORAGE FEE.
